declare under our sole responsibility that all our products meet the requirements of Directive 2011/65/CE RoHS 2 (and subsequent amendments) issued by the European Parliament.

Especially we state that our products are missing the following substances: Lead (Pb), Mercury (Hg), Cadmium (Cd), Hexavalent Chromium (Cr VI).

In accordance with European Union regulation called REACH (Registration, Evaluation, Authorisation and Restriction of Chemical Substances), No. 1907/2006, we declare to be a downstream: we don't produce or import chemicals. We apply for what of our competence- REACH regulation scrupulously following points under the legislation: 1907/2009; 552/2009; 109/2012; 125/2012; 1272/2013.

We attest that all our products are compliant to what specified in the ECHA site for "chemicals of concern" and we confirm that none of the products delivered to our customer contains toxic or in any case harmful substances to environment and human health registered in the "Candidate List of Substances of Very High Concern" -SVHC- (see http://echa.europa.eu/candidate-list-table) updated on the June 27th, 2024.
