ENVIRONMENTAL RESPONSIBILITY	Cavi F.E.R.M.I. srl expects its Suppliers to be aware of the impact of their activities on environment and local communities, and therefore to be committed to environmental protection, efficient use of natural resources and reduction of polluting emissions.

VOLUNTARY AND REGULAR LABOUR	Cavi F.E.R.M.I. srl requires all Suppliers to reject all forms of child, forced and compulsory labour. Suppliers undertake to employ workers with regular residence permit, under a regular employment contract and in accordance with local regulations.

HEALTH AND SAFETY	Each Supplier shall ensure healthy and safe working conditions for each worker, wherever they are. Cavi F.E.R.M.I. srl requires compliance with world health organization regulations as well as a commitment to continuous technological improvement in workers protection.

PROTECTION OF HUMAN RESOURCES	Suppliers undertake to protect the Equality and Human Dignity within their organisation. Cavi F.E.R.M.I. srl shall not accept any discriminatory behaviour (whether based on gender, age, sexual orientation, ethnicity, language, religion, political opinions, personal or social conditions) or harassment, intimidation or

SUPPLY-CHAIN OF SUPPLIERS	Cavi F.E.R.M.I. srl demands that all supply-chain complies with its principles. As a consequence, Suppliers may not entertain or maintain business relations with counterparties whose behaviour is not in compliance with the content of the Code

CONFLICT MINERALS	On August 22nd 2012 the U.S. Securities and Exchange Commission (SEC) adopted the Conflict Minerals provision of the Dodd-Frank Wall Street Reform and Consumer Protection Act, Section 1502. Cavi F.E.R.M.I. is committed not to source any supplies that are derived from minerals originating from conflict regions.

REPORTING NON-COMPLIANT CONDUCT	Any conduct not in compliance to the above principles as well as to Cavi F.E.R.M.I. srl Code of Ethics or the law must be reported to Cavi F.E.R.M.I. srl.

CONFIDENTIALITY	All information provided by Cavi F.E.R.M.I. srl to a supplier shall be presumed to be strictly confidential until proven to be in the public domain.
